

Introduction

Runners Point values its vendors and suppliers and continuously tries to improve its supply chain to minimize the time and cost to move its merchandise from factory to store.

In an effort to streamline this process, Runners Point has developed a Vendor Standards Manual (the "Manual"), which summarizes its supply chain processes and the packaging and labeling requirements that our suppliers have to follow. This program is designed to monitor fulfillment of Purchase Order commitments, identify variances and communicate compliance. We will work with you to help eliminate root cause of variances, resulting in a benefit to both parties. This will involve site visits between our facilities to understand fully the impact of our guidelines.

The attached document contains the 2017 version of the Manual.

This Manual replaces all current Manuals or guidelines.

All orders received at the Runners Point Distribution Center will be monitored for compliance and all deviations from these guidelines will be reported to you, so that you may change processes to achieve compliance.
